**PR release strategy**

we have gone through the BRD. We need confirmation on the points below which have been already discussed.

There were two options given to the VEPL team; one is to have the department wise purchasing group & base on that release strategy setup at item level. which is best practice suggested from our side but as discussed in a meeting business requirement is PR release strategy should be on header level.

To have a department wise release strategy at header level there is a need to create separate PR document type for each department which will increase the document types. New release strategies need to be created for separate departments as per the requirement.

So existing release strategy setup will be followed with new document types to set up department wise release strategy.

Please confirm the same and accordingly update the BRD.

The assumption is that there is no requirement to change the PO release strategy setup.

After the confirmation from your side efforts Estimation with bifurcation will be provided for approval.
