As discussed in the call, I have removed ME55 from the above roles.

For a temporary basis, Shirish Sarade and Surendra Takawle users are granted ME55 access via the role <u>ZD:PS:TOP MANAGEMENT O&M</u> which is assigned to only them.

New Derived roles are created plant wise for restricting ME55 access as mentioned in the attached sheet.
