As mentioned, please follow steps

- 1. Ask BASIS to provide FBXX tcodes access to required roles/users in PRD
- 2. Ask a few users to check whether they are able to PARK the document using FBXX tcode
- 3. We will move the TRs to PRD
- 4. Users will now be able to only PARK documents using FBXX in PRD
- 5. Post settlement time of 1-2 days, ask BASIS to revoke FVXX access to all users. FVXX to be provided to only those users who are allowed to directly POST the documents (without parking)
- 6. Review FBV0 authorization to users. FBV0 is used to POSt the parked document.
