Our SAP go-live was done on 1 Oct 2022. Asset balances were uploaded upto period March 2022. System needs to calculate depreciation from period 01/2022 (April 2022) and post all depreciation from period 01 to 07 in October 2022. System follows April - March Financial Year.

Issue: Planned depreciation in asset values are showing individually from period 1 to 7 instead of consolidated in period

We have checked OAAQ, in which transfer date is correctly updated as 30.09.2022. PFA screenshot 3.

We have checked table TABA, in which no entries found. PFA screenshot 4.

We have checked table T093D, in which Depreciation Posted Upto field is blank. PFA screenshot 5.

Here in HANA, we maintain Legacy Data transfer date in OAAQ (Attachment: SS02).

In QAS system, we have maintained Legacy Data transfer date in OAAQ and values in TABA and T093D was filled automatically. PFA MS word file for reference. Depreciation is calculated correctly in QAS.

As we already communicated, OAAQ is already maintained in the Production as well in the same way. Still, there is an issue in depreciation calculation.

So, we believe it is an inconsistency in system rather than a consulting issue.
