The connection to your Test System QS4 is currently not possible. Therefore, I would like you to check the following information:

When a transfer posting is made, to send the stock FROM the normal, anonymus warehouse stock INTO the valuated project stock, we are transferring stock between two different segments which could be valuated at different prices. Refer to tables MBEW and QBEW.

The stock situation (MBEW) right before this goods issue was posted, was:

Material 170000242 Stock = 0,105 TO Value = 5.250,00 INR

Material 1700000243 Stock = 1,550 TO Value = 77.500,00 INR

As you can see, we did not have value enough to carry out the posting at the value given externally: If we issue -5.859,97 INR (material 1700000242) and -85.907,24 INR (material 1700000242), the value of the stock would have run into negative figures, which is not allowed.

We, therefore, cleared totally the value of the stock (posting -5.250,00 INR and -77.500,00 INR to the Stock Account BSX) and posted the differences to the AUM account.

Have modified KBA <u>0002624573</u> to include this constellation.
